Presentation on Cybersecurity: Securing the Manufacturer meeting compliance

Our South Central Coast Regional Consortium (“SCCRC”) is designing training for Manufactures through the MEP (Manufacturing Extension Partnership) to assist with annual contract compliance to include : security auditing, development of a security plan and development of a POAM (Plan of Action and Milestones) In particular, the SCCRC is designing a training program for DFARS Audit Compliance, a security plus certification program that is a mixed mode of online and/or in person training through the SCCRC Community College Districts in the region.

5. Dr. Tiffany Morse: VCOE Director, CTE Funding AB 1743

K-12 Career Tech Programs, funding comes to an end at the end of 2018. The Assembly originally proposed \$500 million to cover the cost of CTE programs, but the final result was an allocation of \$300 million coming from two sources, \$150 million through competitive grants awarded by the State Dept. of Education and \$150 million in Strong Workforce dollars that will come to K-12 via competitive grants submitted to the Community College Districts. Funding will not be decided until May but teacher contracts are signed in March. Lay offs will be made. In Ventura County there will be one county-wide application for grants made to both funding sources. VCOE will request letters of support from the community to submit with its application, potentially due in January.
